Criminal justice reform

I strongly oppose any federal legislation that violates individual rights by requiring individuals to purchase a particular good or service.

This is accomplished with competition among nationwide healthcare providers, health savings accounts, fewer mandates, tort reform and streamlining processes to increase efficiencies and decrease cost.

Physicians, healthcare providers, and healthcare organizations must retain the right to practice in a manner they believe is ethical and to exercise freedom of conscience."
