15	herein, and am competent to testify thereto.
16	2. I am Senior Attorney with the Spokane County Public Defender, where I have
17	worked since November 12, 1996. I have been a team leader for the Spokane County Public
18	Defender felony attorneys since January 2014.
19	3. Currently, I represent M.W. Attached as Exhibit A is a true and accurate copy of
20	my motion, declaration, and memorandum to show cause regarding his delay in obtaining
21	competency evaluation from Eastern State Hospital ("ESH").
22	4. M.W. was booked into the Spokane County Jail on September 22, 2014. Ex A, p.

1 5. M.W. was court ordered to receive a competency evaluation from ESH on October 2 1, 2014. Id. at 2 and 12.

ESH received a copy of the court order on the same day. Id.

7. After I made several phone calls to try and schedule the evaluation, ESH finally scheduled the evaluation for November 12, 2014, or forty-three days after the court order was entered and received by ESH. Id. at 2. I have since learned that ESH has rescheduled the evaluation for November 13, 2014.

8. On October 22, 2014, I submitted my motion to show cause along with a declaration, exhibits, and memorandum regarding the delay in obtaining the court ordered competency evaluation. Id.

11 9. On October 27, 2014, I informed ESH of the October 30, 2014, hearing date for 12 my motion to show cause. Attached as Exhibit B is a true and accurate copy of the email exchange.

14 10. On October 28, 2014, Assistant Attorney General ("AAG") Andrea Utigard replied stating, "This case is currently set for a motion for an order to show cause and ESH is not a party 15 16 the criminal action. The Attorney General's Office will attend a hearing on this case if an Order 17 to Show Cause is entered with regard to ESH." Id.

18 11. On October 30, 2014, the court rescheduled the show cause hearing for Friday, 19 November 7, 2014.

20 12. On October 31, 2014, I also received a response to a Public Disclosure Act request I sent to ESH on October 21, 2104. A true and accurate copy of my PDA request and ESH 21 22 response is attached is Exhibit C. According to the information provided by ESH, there are

ninety-four people waiting, on average, forty-three to forty-five days for competency evaluation. 2 Id.

13. These wait time averages are consistent with what my client, M.W., and others like him are experiencing while they decompensate in jail due to their mental illness. Just today, M.W. called me and left me an angry voicemail. Even though he had attended last week's hearing regarding my motion to show cause, M.W. was confused regarding why he had not been evaluated and was still in jail. I have noticed that he has become more volatile the longer he waits in jail for these court-ordered services.

I declare under penalty of perjury under 28 U.S.C. § 1746, that the forgoing is true and accurate.
